## ZACHARIAH DUTTON

Many of Zachariah Dutton's off-springs settled in the Lawrence and Morgan Counties area. Most of the children were born in Maryland (probably Chares Co.,) as Zack Sr. was found there on the 1790 Census with 5 males under 16, and 3 females listed. Zack Sr. was in Granville Co., NC by 1798 and possibly earlier, he re-married in November of 1798 to the widow of Claborn Parrish.

This information is the speculation sheet on the possible descendants of Zachariah Dutton.

- 10. Elizabeth, named in will as Elizabeth Baley, possibly born of Judith & Zack, ca. 1800..DwC may m. William Bailey, records for Granville Co., show a marriage between Wm. Bailey & Betsy Dutton in 1817

"WILL OF ZACHARIAH DUTTON"

IN THE NAME OF GOD, AMEN! I, ZACHARIAH DUTTON, of the county of Granville, (North Carolina) etc...being of sound & vigorous mind... etc...do: On this 10th day of November 1828 make and publish this my last will for disposition of that portion of the worlds goods:

ITEM: It is my will that at my death or as soon thereafter that may be proper that my executor sell my property, both Real & Personal, to proceed to the collectio, getting it all together, then to distribute it in the following manner -VIZ:

FIRST: To pay my due debts, then to set apart the sum of \$150, to be kept at interest, until the YOUNGEST child of my Son, John, shall become of lawful age, then to divide the amount equally amongst the children of my Son, John- Or if my executor chooses, he may pay them off respectfull(sic)(respectively), as they arrive at lawful age. The balance of my estate may be distributed in the following manner: SAY TO:

- To my dau: Matilda, 5 Shillings
- to my son: Zachariah, 1/8th-subject to deduction of \$125.00
- To my son: William: 1/8th " " " \$165.00
- To my son Alexander, 1/8th " " " \$100.00
- To my son: Jarrott, 1/8th " " " \$ 25.00
- To my son, Samuel, 1/8th " " " \$200.00
- To my dau: Elizabeth Bailey - subject to NO deduction!
- To my son Edmund, 5 Shillings/having his part in Land
- To my son Stephen, 5 Shillings/having his part in Land
- To my son John, 5 Shillings/\_\_\_\_\_

The remainder to be distributed by our acts of assembly for distribution.

I hereby nominate-constitue & appoint my friend, David J. Young, my whole & sole Executor to settle & distribute my property and executor, this my last will & testament.

The above proved in open court--by oath of David Owing, Jr., swearing he saw Joseph Hart in presence of testator--August Sessions of Granville Co., -1829 - David I (?) Young appeared as Executor of Zachariah Dutton, dec'd, and was qualified to order such to be recorded, (Steph. Sneed, C.C.C...or appears to be..DWC
